



# Salmon River Central School District PROPOSED 2013-14 BUDGET

## A Message from the Superintendent and Board President:

On Tuesday, May 21, 2013, District residents will go to the polls to vote on a proposed \$29 million budget for the 2013-14 school year. In light of increasing obstacles, the Board has developed an educationally and fiscally responsible budget, working very hard to maintain current staffing levels through a combination of reasonable tax increases with responsible use of fund balance. During these tough fiscal times we have had to be creative and find ways to cut costs without cutting staff and maintaining all programs.

The 2013-14 tax levy increase is 2%, which remains below the NYS Tax Levy Cap. The Board did not follow the tax levy cap which would have been 11.37%. The Board understands that with the uncontrollable increases in the health insurance and retirement costs it is necessary to increase the tax levy. Therefore, the levy will only increase by 2%, not 11.37%, and the balance will come from the District's reserves.

The District is extremely mindful of the responsibility to provide an educational program that meets the needs of our students and is affordable. Throughout the budget process, we sought to identify reductions that would maximize the time and skills of our staff and allow us to sustain the caliber and breadth of learning opportunities we currently offer. We recognize the limit of the fiscal resources of our community, as well as NYS. It is a tribute to the efforts of the Board of Education, administrators, teachers and staff, that we have been able to preserve educational programs for students.

We are very proud of the academic rigor of our programs and will continue to challenge our top students with honors and advanced placement courses. We are also extremely proud of all our athletes' accomplishments, not only for their skill and ability, but also their sportsmanship and commitment to academics. We would like to congratulate Girls Volleyball and Girls Basketball who won Section X championships this year.

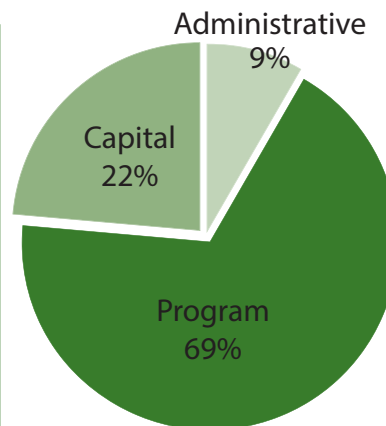
books are in the library. Colonie Gray (7th grade) and Jalen Cook (6th grade, pictured left) had the

## GO SHAMROCKS!!

### Sources of Strength

Now in its fourth year at Salmon River, Sources of Strength is a best practice youth suicide prevention project that utilizes the power of peer social networks to change unhealthy norms and culture and ultimately prevent suicide, bullying, and substance abuse. The program is designed to prevent suicide by increasing help-seeking behaviors and connections between peers and caring adults with a focus on *Hope, Help, and Strength*.

Students meet at least once a month with peer leaders from grades 9-12. Peer leaders are chosen by a member of the staff or by another peer leader.

The program helps students learn who the “trusted adults” in the school are. The key goal of SOS is to increase positive help-seeking behaviors among ALL students in school and break down “codes of silence” that often keep teens from seeking adult help when in crisis. University of Rochester provides training, technical support, and supplies.



Students have participated in the Akwesasne walk for Suicide and Addiction Awareness and have also recorded a suicide prevention public service announcement to run on CKON radio. The group has also done morning announcements and bulletin boards.

## Beginning With Books

Now in its 15th year, Beginning with Books is a free program for community children, designed to foster a love of reading through books, crafts, and other activities. The program is geared to children aged infant to school age. The story and craft hour is held on Wednesdays at 10:00 AM in the Elementary School.



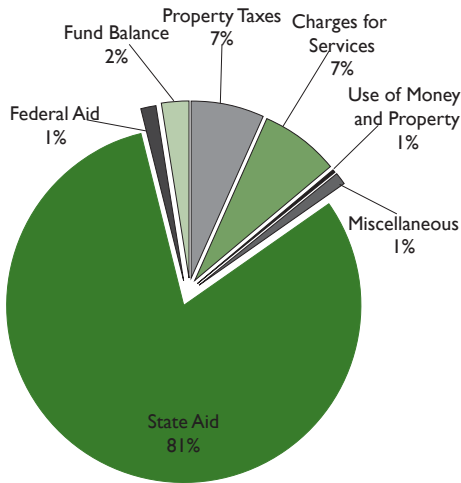
“This is a great program to help students get ready to attend school because they gain a familiarity with the school and what it is like to be in a school setting,” noted program leader Kim Russell.

According to Ms. Russell, students sometimes attend the program for 1-3 years prior to beginning school, which is helpful in providing an opportunity for young children to interact with others.

The program averages 10-14 children a week and high school seniors assist with crafts and snack time.



## Revenues 2013-14



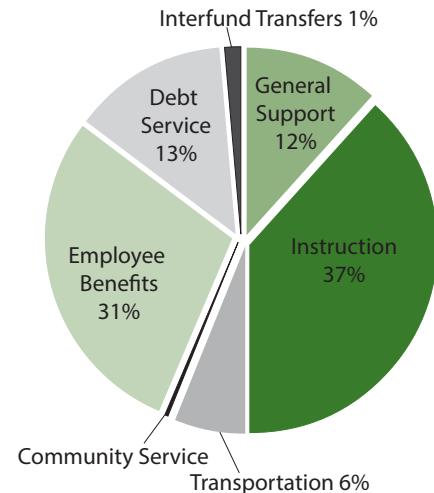

## Bus Purchase on Ballot

A proposition on May 21st will ask voters to approve the purchase of two (66) passenger buses at a cost not to exceed \$210,000. The state reimburses the District for 90% of bus purchases, therefore the local taxpayers' share of the total would be an average of \$4,800 for the next five years.

**Why does the District purchase buses on a regular basis?** The Salmon River Central School buses travel an average of 375,000 miles each year and carry 1,500 students daily. The District has an ongoing bus replacement plan designed to keep the bus fleet in safe, working order. New bus purchases replace old buses based on the vehicle's mileage, age, repair history, and condition. As buses age, they become more costly to maintain and less efficient to run. Older engines can average only about six miles per gallon; new buses should average about nine miles per gallon. That difference can add up to considerable savings given the number of miles our school buses travel each year.

## How is the Tax Rate Set?

School districts establish the tax levy, the total amount of money raised by local taxes to fund the school budget, but do not determine what portion of the tax burden is placed on any one town or property owner. Each year the actual tax rate increase/decrease varies from town to town due to changes in the assessed values and equalization rate, which are set by the Office of Real Property Services, and will not be finalized until August.

In late August, the District uses the total taxable assessed value of properties in each of its towns and the state equalization rates to calculate each town's portion of the school tax levy. The portion of the tax levy is then divided by the total assessed value of property in each town to determine the school tax rate per \$1,000 of assessed value by town. Individual tax bills are printed and mailed to property owners.

## How do I estimate my school taxes for 2013-14?

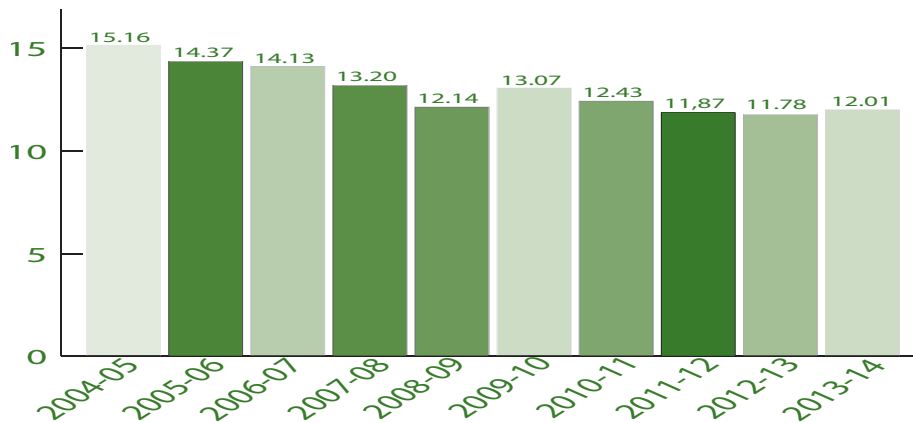
The amount of taxes collected by the District will change 2%. Using the formula below, you will be able to calculate your estimated school tax.

Assessed Value	÷ 1,000	X Tax Rate	- STAR =	School Tax

*Are the tax levy and tax rate the same thing?* No. There is a difference between a school district's tax levy and the tax rate set in August by the Board of Education. The tax levy is the total amount of money that a government entity, like a school district, collects each year in taxes from property owners. The tax rate is the per \$1,000 of assessed value figure used to compute tax bills and based on a home's individual assessment. It is determined by using town-wide assessments (the total value of all town property) and state equalization rates (release by the state in August by the Department of Taxation and Finance).

## True Tax Rate 2004-2014

*Why has the tax rate gone down?* Over the past nine years, the tax rate per thousand has gone down from \$15.16 per thousand in 2004-05 down to \$12.01 per thousand. This is caused by the increasing assessments from the towns. For 2013-14, the estimated property tax bill for the average \$50,000 home will increase \$19 and a senior citizen will see no increase in their property tax bill based on the current assessments.

## Robotics

The high school robotics team competed in the FRC "Ultimate Ascent" game this year. The team had six weeks to design, build, and program a robot to play ultimate frisbee. The team was awarded a couple of large grants this year, allowing for students to be able to build two robots (#229 and #4124). Both robots were designed to shoot frisbees across a court into targets and were built to hang from a horizontal bar on a tower for bonus points in the game.



In early March, students brought the twin robots to the FIRST Granite State Regional in Manchester, NH, where they competed against 43 other teams from all over the US and Canada. Robot 4124 was the 3rd best performing robot at the competition, was the #1 pick in the elimination matches, and was selected by the #1 robot to be in their alliance. Robot 229 went to Boston two weeks later to compete in the FIRST Boston Regional against 50 other teams from across the US, Canada, and Brazil. The team was seeded 10th at the end of the 84 qualifying rounds and was selected by the 5th seed team to go into the finals, and in the end, won the Judges Award for excellent engineering design!



## Did you know?

- ☑ The Girls Volleyball team won the Class C Championships and the Girls Basketball team won the Class B Championships and made their 2nd Final Four appearance. Also, last spring the Boys Lacrosse team won the Class C Championships.
- ☑ Abby Kelly scored 1,000 points, breaking the school record in scoring.
- ☑ During the fall and winter, 312 students participated in athletics at Salmon River Central - 162 boys and 150 girls - in grades 7-12.
- ☑ This spring, 200 students - 120 boys and 80 girls - will be participating on eight athletic teams.

## Community Use

The Salmon River School facilities are open for public use. Two programs that are offered to the community are Free Open Swim and Free Open Skating.

Free skating is offered from early October-March on Saturdays from 6-8 pm and Sunday 2:00-4:00 pm. In addition, the Parents with Tots program is available on Wednesdays and Fridays from 10:00 am to 12:00 pm. Everyone is welcome; just bring your own skates.

A locker room is available for all public skating sessions, with small lockers to use as well. During this past ice season, there was an average of 24 participants during each two hour public skating session. The ice rink is also used by local youth organizations, including North Franklin Hockey and Shamrock Figure Skating, and is rented on a regular basis by several adult groups and other area youth organizations.

Free swimming is offered on Wednesday nights from 6:00 to 8:00 pm, during the school year. There is a certified lifeguard on duty and all are welcome!

**Did you know?** Swimming uses all the major muscle groups and water provides 12 times the resistance of air, which boosts muscle strength. A study at Indiana University found long-term swimmers aged over 40 who swam more than four times a week showed fewer signs of aging than the general population.

## Salmon River Girls Basketball

The Salmon River Girls Varsity Basketball team completed the season with an overall record of 17-7. They won the Class B title for the third consecutive year in a row and went on to win the Regional Championship, earning them a spot in the Class B Final Four tournament on March 15th. Jocelyn Martin and Abby Kelly earned the All-Academic Award, and Zaagaate Jock won the Section X Sportsmanship Award.

In addition, Abby Kelly broke scoring records when she hit her 1,000th point on January 4th. She is the all-time girls leading point scorer with 1373 points. She also holds the record for most points scored in one game with 48 points. Abby earned 1st Team All-Northern as well as a spot on the All-State tournament team at the Final Four. Jaiden Mitchell was selected as the sportsmanship winner at the Final Four tournament.

## Qualifications of Voters

To be eligible to vote, a person must be a citizen of the United States, at least eighteen years old, a resident of the school district at least 30 days, and must not be prohibited from voting under the provisions of section 5-106 of the Election Law, for example, as a result of having been convicted of a felony or adjudged mentally incompetent.

## Absentee Ballot

Qualified district residents who are unable to go to the polls on May 21st can cast their votes by absentee ballot. For an application, stop in at the District Office or call District Clerk Natascha Jock at 358-6608. Applications must be received in the Superintendent's Office at least seven days prior to election (by May 14, 2013) for ballot mailing. All completed ballots must be received by the District Clerk no later than 5:00 pm on Tuesday, May 21, 2013.
