A MESSAGE FROM SUPERINTENDENT DR. STANLEY HARPER

Looking forward to the 2025–2026 school year, I want to share an overview of our proposed budget and its impact on our Shamrock Community. Despite some funding uncertainties at the state and federal levels, this budget prioritizes our students while ensuring responsible use of taxpayer money.

Our students are always our focus. Each year as we develop the budget, we ask: "How will this help our students learn and achieve their aspirations?" The proposed budget for 2025–26 reflects this dedication by supporting excellent teaching, investing in our team, and maintaining secure and welcoming learning spaces. We've carefully balanced resources to advance academic success while addressing increasing costs in areas like staffing, health benefits, utilities, transportation, and technology.

The budget also preserves all existing academic, arts, athletics, summer school and extracurricular offerings. STRATEGIC PLANNING

TAX LEVY IMPACT

The proposed budget includes a 2% increase in the tax levy, which remains within the district's allowable limit under New York State's tax cap law. As a result, it requires only a simple majority for approval. We believe this proposal strikes the right balance—addressing immediate priorities while planning strategically for the future. It's a responsible, student-focused approach that ensures continued progress for our district. GRADUATION RATE STAYS STRONG!

The Salmon River Central School District maintains a strong emphasis on regular attendance, recognizing its crucial role in student learning. For the 2020 cohort, the four-year graduation rate (by August 2024) was an impressive 92%. This reflects the district's commitment to seeing its students successfully complete their high school education. With an enrollment of approximately 1,385 students in grades Pre-K through 12, the District maintains a student-teacher ratio of 9 to 1.

DRONE SOCCER: ANOTHER SUCCESSFUL YEAR!

The SRCSD Drone Soccer team has wrapped up its second exciting year! This innovative program allows high school students to compete in drone-based soccer, a thrilling mix of robotics and sportsmanship.

Fueling our success: We're proud to partner with the New York Power Authority (NYPA)! In March, NYPA representatives visited Salmon River, showcasing cutting-edge drone and robotic technology to students of all ages



VOTER QUALIFICATIONS

QUALIFIED VOTERS ARE

- At least 18 years old
- A U.S. citizen
- A District resident at least 30 days prior to the vote

ABSENTEE BALLOTS

To vote by absentee ballot because you are unable to attend the in-person vote, you must fill out an application. Please contact the District Clerk at 518-358-6614. If you want a ballot mailed to you, your application must be received seven days before the vote. If you plan to pick up your ballot, your application must be received one day prior to vote. Completed absentee ballots must be received by the District Clerk by 5 p.m. on May 20, the day of the vote.



WEATHER WONDERS AT SALMON RIVER

Students across the North Country experienced the excitement of broadcast meteorology firsthand thanks to visits from the WPTZ NBC5 First Warning Weather team. Meteorologists took their expertise and even their mobile weather lab directly to local schools, sparking curiosity and inspiring young minds about the science of weather.

Salmon River Central School District had the special opportunity to host the WPTZ team not once, but twice this school year. In



November, My NBC5 meteorologist Marissa Vigevani brought their "Weather at Your School" program to Salmon River students. They shared insights into weather forecasting and the technology used to keep the community informed.

Adding to the weather excitement, Salmon River also welcomed NBC5 First Warning Meteorologist

Andrew Grautski last month. During his visit, Andrew engaged with 3rd-6th graders, discussing various weather phenomena and answering their insightful questions. These visits provided invaluable learning experiences for the students, bringing the often-abstract concepts of meteorology to life. The hands-on exploration of the Weather Lab and the chance to interact directly with broadcast professionals like Andrew and

Agriculture plays a vital role in our community, and Salmon River students are actively engaged in hands-on learning experiences that foster this connection. Guided by dedicated teacher Michelle Oakes, students are involved in a range of exciting hands on projects.

Enhancing Our School Environment: For the past two years, students,

under the direction of Ms. Oakes and former educator Bruce Bonesteel, have undertaken landscaping projects that have enhanced the entrances of both the Main campus and the St. Regis Mohawk School.

Developing a Community Resource: Middle and high school students are currently developing a community garden behind the Middle School, which will feature flower beds and other student-designed elements.

BUDGET: \$41,444,974

Shall the annual school budget, in the amount of \$41,444,974 for the fiscal year beginning July 1, 2025, and ending June 30, 2026, as prepared by the Board of Education and filed at its office, be adopted and the requisite portion thereof be raised by taxation on the taxable property of the district?

The School Board election will be held on May 20 to elect three members of the Board of Education as follows: two members to five-year terms commencing on July 1, 2025 and expiring on June 30, 2030, an one member expiring June 30, 2027.

PROPOSITION ONE: Student Transport Vehicles

RESOLVED, that the Salmon River Central School District is hereby authorized to purchase and finance student transport vehicles, and expend a total sum not to exceed \$650,000, which is estimated to be the total maximum cost thereof.

PROPOSITION TWO: \$47,000,000 Capital Improvements

Voters will be asked to authorize a capital project to renovate and upgrade facilities at a cost not to exceed \$47 million. These renovations will ensure an environment that is safe and secure for our students.
