4. Reports and Presentations

Report: A. Academic Program Report

Angela Robert's report provided an overview of the updated Professional Development Plan along with a brief presentation of one of the new proposed courses to be offered to High School students. The Professional Development Plan is an update to the existing plan that has incorporated any professional development that is required or possibly requested based on NYS and federal mandates, the needs identified through both student data and staff evaluations, as well as staff feedback and requests. The ultimate goal continues to be the improvement of student learning. Please see attached for more details. There was also a curriculum subcommittee meeting held to allow committee members to talk with the High School principals about the new course proposals for next year. The list of new courses is listed as an action item on tonight's agenda. Brandi Harris and Brigette Palmer both gave a brief presentation as well regarding the Drone Curriculum Outline and Drone Soccer. Brigette presented a drone at the Board meeting for board members to see. Brandi and Brigette both spoke about the need for this curriculum at the Salmon River Central School. There are currently 1,782,479 drones registered in the United States. Bringing the Drone Curriculum to the District will bring in 21st Century skills which will teach the needs of today's society, critical thinking, citizenship, growth of mindset, while increasing communication, creativity and collaboration. The Drone Soccer program will appeal to a whole new set of students, broadening the sports field in yet another direction. More information attached. Board President Emily Lauzon asked about coverage for these new courses as we are already facing staffing issues. Teresa VanDunk spoke to this, confirming that this will not be an issue. Current staff will be covering these new electives. There will be some changes to course offerings and we will have full coverage. No new staff will be needed. Angela Robert closed her report advising that Brandi Harris, Lorraine Childs and Norman Treptow will be at the St. Regis Mohawk Tribe

Report: B. Superintendent's Report

Dr. Harper began his report sharing some exciting news. Dr. Harper had reached out to the Commissioner of Education to visit our school district. Dr. Rosa along with Dr. Young (the NYS Chancellor of Education) responded that they would visit our District. In addition to the District, a trip to meet with the Tribal Counsel was to be scheduled as well. The tour will include the St. Regis Mohawk School to start the day, followed by a visit to the St. Regis Mohawk Tribal Counsel. The visit will be continued at the main campus visiting first the High School and closing out the day with the CTE/Welding program. Numerous students have also agreed to speak with the Commissioner and the Chancellor. This is a great experience for these

students. Dr. Harper plans to discuss the continued need for a new elementary school to replace the St. Regis Mohawk School on higher grounds. We are honored that the Commissioner has agreed to this visit! Dr. Harper also touched on the need for assistant coaches as needed and only by the recommendation of the Athletic Director and the Superintendent. There will be an action item on the agenda regarding this. Dr. Harper closed out his report acknowledging the Boy's Hockey Team for their consistent hard work, and determination. Their collective work and sportsmanship brought them to the NYS Championship Final Four. In addition, Coaches Tim Cook, Peter Durant, Ted Cook and Shawn Miller were named the NYS Division II Coaches of the Year. Players Evan Collette and Luke Miller made the First Team Division II State Hockey Team while Connor Dishaw had Honorable Mention for the NYS Division II State Hockey Team.
