

Annual Election and Budget Vote (Tuesday, May 16, 2023)

1. Call to Order

The Chairman opened the meeting at 11:55am.

2. Notice of Annual Meeting

A motion was received from Lindsay Chapman, seconded by Kimberly Treptow to dispense with the reading of the formal Notice of the Annual School Meeting.

3. Roll Call of Inspectors

Chairman Treptow called roll call of the Election Inspectors. All were present.

4. Polls Opened

Chairman Treptow opened the polls at 12:00pm and voting commenced.

5. Polls Closed

At 8:00 pm the Chairman closed the polls. The votes were then tabulated.

6. Budget Vote

The Chairman announced the following results:

Shall the annual school budget, in the amount of \$36,886,087 for the fiscal year beginning July 1, 2023 and ending June 30, 2024, as prepared by the Board of Education and filed at its office, be adopted and the requisite portion thereof be raised by taxation on the taxable property of the District?

Shall the Board of Education of the Salmon River School District be authorized to purchase and finance replacement student transport vehicles, including necessary furnishings, fixtures and equipment and all other costs incidental thereto, and expend a total sum not to exceed \$1,400,000, which is estimated to be the total maximum cost thereof, and said amount, or so much thereof as may be necessary, shall be raised by the levy of a tax upon the taxable property of said School District and collected in annual installments as provided by Section 416 of the Education; and, in anticipation of said school district, in the principal amount not to exceed \$1,400,000 shall be issued:

Shall the Board of Education of the Salmon River Central School District be authorized that commencing with the 2023-2024 fiscal year and extending through the 2024-2025 fiscal year, the Salmon River Central School District Board of Education shall have a non-voting student representative thereupon and such representative shall be entitled to participate in all Board of Education public hearings and meetings but shall not participate with respect to any and all executive sessions of the Board of Education, same to be in accordance with Chapter 267 of the Laws of 2003.
