

THREE PART BUDGET

The state requires school districts to present their annual budgets in three parts: administrative, program and capital. Below is the breakdown of SRCSD's three part budget.

PROGRAM BUDGET

2024-25 \$ 27,210,629 70.36% 2023-24 \$ 24,307,898 66%

Program costs include salaries and benefits for teachers and staff delivering pupil services, i.e. health, guidance, library, and athletics. Also included: textbooks, instructional materials, equipment, extracurricular activities, BOCES program costs, and all transportation costs except bus purchases.

CAPITAL BUDGET

2024-25 \$ 7,954,093 20.57% 2023-24 \$ 9.394.643 26%

Capital costs include the salaries and benefits of maintenance and custodial staff, plus debt service, bus purchases, utilities, general insurance, tax certiorari, and other court-ordered costs.

ADMINISTRATIVE BUDGET

2024-25 \$ 3,508,472 9.07% 2023-24 \$ 3,183,546 8%

Administrative costs include the salaries and benefits of all certified staff who spend 50% or more time in administration. Also included are: clerical staff, school board costs, curriculum costs, tax collection, legal and auditing costs, central printing, central data processing, BOCES administrative costs, research, planning, and evaluation.

pitches. After having just one week to actually make the products in school, students sold them to community members on Nov. 20, 2023. All the proceeds went toward the class trip to Boston later this year.
















HARVEST OF THE MONTH MENU **SPOTLIGHT!**


As always, the food service staff continues to do an extraordinary job taking care of district students.

Solar Energy Initiative



The upcoming capital project aims to take another major step forward in its commitment to sustainability with a new solar energy project, a direct reflection of the District's dedication to reducing its carbon footprint while providing valuable educational opportunities. The \$16 million solar project involves the installation of a 5-megawatt solar array on approximately 16 acres of unused wooded land located behind the track. These solar panels will harness the abundant renewable energy provided by the sun, offsetting the District's electricity consumption.

Key highlights of the initiative include:

ENVIRONMENTAL IMPACT:

Harnessing solar energy will eliminate reliance on traditional energy sources, resulting in a reduction of greenhouse gas emissions and other pollutants.

EDUCATIONAL OPPORTUNITIES:

The installation of solar panels will serve as a hands-on-educational tool for students, providing valuable learning opportunities about renewable energy, sustainability, and environmental conservation.

FINANCIAL SAVINGS:

Using solar energy will lead to significant cost savings for the District by eliminating all electricity expenses. Combined with available Federal and State aid, the project will be paid for in less than 1 year.

COMMUNITY ENGAGEMENT:

Demonstrating a commitment to community engagement

and collaboration and serving as a tangible example of how public institutions can lead by example in promoting sustainability.

"We're excited about setting an example for green technology and the educational opportunity for students to learn about renewable energy," noted Superintendent Dr. Stanley Harper. "By embracing solar energy, we are not only investing in a sustainable future, but also in significant cost savings, ensuring that precious resources will continue to be directed towards the education and wellbeing of our students."
