**PROPOSITION NO. 2**

Shall the following resolution be adopted:

RESOLVED, that the Salmon River Central School District is hereby authorized to undertake a capital improvement project consisting of the reconstruction and renovation of, and the construction of improvements, additions and upgrades to various District buildings and facilities and the sites thereof, including the main school building, the bus garage and the District's sewage treatment plant, as well as construction of a new storage building, installation of synthetic turf infields, expansion of the District's geothermal heating system and the purchase of original furnishings, equipment, machinery and apparatus required in connection with the purposes for which such buildings, facilities and sites are used, all to include site, access, lighting, parking, athletic field, stadium and playfield improvements, demolition, utility, mechanical, plumbing and electrical improvements as well as payment of professional fees and all other necessary costs incidental to such work (collectively, the "Project") and expend therefore a total sum not to exceed \$47,000,000, which is estimated to be the total maximum cost thereof, and to pay for the Project by spending \$1,500,000 of available funds, and by the levy of a tax which is hereby voted in the amount of \$45,500,000, subject to available State aid or to any other revenues available for such purpose, which tax shall be levied and collected in annual installments in such years and in such amounts as may be determined by the Board of Education and in anticipation of the collection of such tax, bonds and notes of the District are hereby authorized to be issued at one time, or from time to time, in the principal amount not to exceed \$45,500,000, and a tax is hereby voted to pay the principal and interest on said obligations when due.
